SUREFOOT ELIGIBILITY: FIS race open to SR U21 U19

RULES: All FIS & USSA rules will be in effect. No lift line cutting.

ENTRY FEE: \$35 per race. Top five point holders **refunded** their entry fee if their USSA points are fewer than 30.00.

LIABILITY RELEASE: A signed release of liability must accompany all entries. **Bibs will not be issued without a signed release.** Releases may be emailed to emartin@winterparkresort.com or faxed to 970-726-1690 or 303-316-1690. Coaches can bring all athlete releases to Team Captain's Meeting on Feb. 18th in order to receive bibs. You only need to complete the release once during the 2015/2016 season.

LIFT TICKETS: \$ 45 per day. **Purchase at race registration.** Cash, check, or credit card.
Coaches must present a current USSA membership card to receive a complimentary ticket.
(1 coaches ticket for every 8 racers.)

Deadline for all entries is February 17, 2016 no later than 6:00 pm.

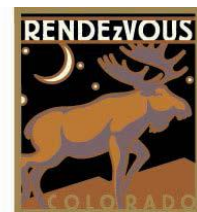
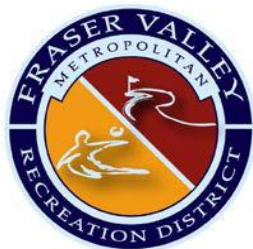
